Specific rules (not a complete list): <ul style="list-style-type: none"> <li>The tournament director reserves the right to make all final decisions regarding this competition</li> </ul>
<b>Judo gi color:</b>	Although optional, USA Judo encourages the wearing of a Blue judo gi by the "blue" side competitor. The "white" side competitor must wear a white judo gi. Competitors are responsible for appearing in the correct color gi. Under no circumstances shall both competitors be allowed to compete in blue gis, nor will the blue and white competitors be allowed to switch positions. Gi pants and jacket must be the same color.
<b>Anti-Doping Control:</b>	Testing, in accordance with the Anti-Doping Rules and Procedures of the International Judo Federation and U.S. Olympic Committee, and the United States Anti-Doping Agency (USADA), will be conducted.
<b>National Anthem &amp; Flag:</b>	Each team is requested to bring along a normal cassette tape on which its national/regional anthem (short version) is recorded, and hanging national/regional flag having dimensions no larger than 120 x 180 cm.
