I. SELECTION SYSTEM

A. Provide the minimum eligibility requirements for an athlete to be considered for nomination to the Team:

1. Citizenship:

Athlete must be a citizen of the United States at the time of nomination and hold a valid passport that will not expire for six months after the conclusion of the Pan American Games.

In order to be eligible to compete in the 2011 Senior National Championships, an athlete shall meet the PASO Citizenship eligibility requirements prior to commencement of the 2011 Senior National Championships.

2. Minimum International Federation (IF) and/or Continental Federation (CF) standards for participation (if any):

There will be a maximum of one athlete per weight category per country.

The athlete must hold a current USA Judo black belt ranking.

3. Other requirements (if any):

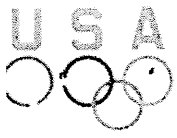
Athletes must be a member in good standing with USA Judo.

B. Tryout Events:

1. Provide the event names, dates and location of all trials, events and camps to be used as part of the selection process.

- C. Provide a comprehensive, step-by-step description of the method that explains how athletes will go through the selection process to become Team nominees (including maximum Team size).

The maximum team size is up to 14 athletes, one representing each weight category. Qualification of each weight category to the 2011 Pan American Games will be determined by the Pan American Ranking. The 14 weight categories are: Men (60kg, 66kg, 73kg, 81kg, 90kg, 100kg, and 100+kg); Women (48kg, 52kg, 57kg, 63kg, 70kg, 78kg, and 78+kg).

The 2011 Senior National Championships shall serve as the selection event for the USA Judo Pan American Team to the 2011 Pan American Games. The 2011 Senior National Championships will be held May, 2011.

Athletes attending the 2011 Senior National Championships shall be seeded according to the established USA Judo seeding protocols. If the #1 seed in any weight category wins the 2011 Senior National Championships he/she shall be the athlete selected in each category of competition. If the #1 seed does not win the 2011 Senior National Championships, then the #1 seed athlete and the winner of the 2011 Senior National Championships shall then engage in a best of three fight-off. The winner of that fight-off shall be the athlete selected for that category of competition. The loser of that fight-off will be selected as the replacement athlete.

In weight categories where fight-offs are needed, these matches will take place immediately following the completion of all gold medal matches during the same day's competition.

All athletes have a maximum of 48 hours from the naming of the Pan American Team to accept or decline their position.

The replacement pool will be:

1. The second place finisher of the fight-off at the 2011 Senior National Championships.

2. In any weight category where there is no fight-off at the 2011 Senior National Championships, the highest ranked athlete according to the



Senior Classification/Point Roster at the close of the 2011 Senior National Championships who competed at the 2011 Senior National Championships will be the replacement.

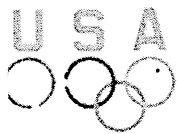

III. REMOVAL OF ATHLETES

- A. Prior to acceptance of nominations by the USOC, USA Judo has jurisdiction over potential nominees.

An athlete who is to be nominated to the Team by USA Judo may be removed as a nominee for any of the following reasons, as determined by USA Judo:

- Voluntary withdrawal. Athlete must submit a written letter to the USA Judo CEO/Executive Director.
- Injury or illness as certified by an approved USA Judo physician (or medical staff). If an athlete refuses verification of his/her illness or injury by an approved USA Judo physician (or medical staff), his/her injury will be assumed to be disabling and he/she may be removed.
- Violation of the USA Judo's Code of Conduct (Attachment A).



An athlete who is removed from the Team pursuant to this provision has the right to a hearing per the USA Judo Constitution and Bylaws, Article 14, or the USOC's Bylaws, Section 9.

- B. After acceptance of nominations by the USOC, the USOC has jurisdiction over the Team under the USOC Code of Conduct and Grievance Procedures. This occurs no earlier than 45 days and no later than 30 days prior to the Opening Ceremonies of the Games (unless expressly waived by the USOC).

A Team member who is accepted by the USOC is subject to the USOC Code of Conduct and Grievance Procedures.

- C. An athlete may be removed as a nominee to the Team or from the Team at any time for violation of IOC, PASO, IPC, WADA, IF, USADA and/or USOC anti-doping protocol, policies and procedures, as applicable. In such instances, the adjudication process will be managed through the United States Anti-Doping Agency.

IV. REPLACEMENT OF ATHLETES

- A. Describe the process by which the replacement pool of athletes will be identified:

The replacement pool will be:

1. The second place finisher of the fight-off at the 2011 Senior National Championships.
2. In any weight category where there is no fight-off at the 2011 Senior National Championships, the highest ranked athlete according to the Senior Classification/Point Roster at the close of the 2011 Senior National Championships who competed at the 2011 Senior National Championships will be the replacement.

USA Judo Code of Conduct

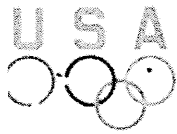
ATHLETE PLEDGE

I pledge to uphold the spirit of the USA Judo Code of Conduct (the “Code”), which offers a guide to my conduct as a member of the 2012 Olympic Team (the “Team”). I acknowledge that I have a right to a hearing if my opportunity to compete is denied or if I am charged with a violation of this Code.

I have familiarized myself with the Code and understand that acceptance of its provisions is a condition of my selection to the 2012 Olympic Team.

As a Member of the Team, I hereby promise and agree that I:

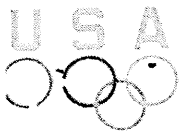
- will abide by all rules related to the Team selection procedures as approved by USA Judo;
- have acted and will act in a sportsmanlike manner consistent with the spirit of fair play and responsible conduct;
- will maintain a level of fitness and competitive readiness that will permit my performance to be at the maximum of my abilities;
- will not commit a doping violation as defined by the International Olympic Committee (IOC), World Anti-Doping Agency (WADA), the United States Anti-Doping Agency (USADA), the United States Olympic Committee (USOC) or the International Judo Federation (IJF) rules;
- am not currently serving a doping violation and/or do not have a pending or unresolved doping charge;
- will not engage in any conduct that is criminal under any laws applicable to me, including, but not limited to laws governing the possession and use of drugs and alcohol and providing of drugs to any person and of alcohol to minors;
- am eligible to compete under the rules of IJF;
- will refrain from conduct detracting from my ability or that of my teammates to attain peak performance;



- will respect the property of others whether personal or public;
- will respect members of my Team, other teams, spectators and officials, and engage in no form of discriminatory behavior or verbal, physical or sexual harassment or abuse;
- will follow my Team's rules, including by way of example, rules regarding curfew and required attendance at team meetings;
- am aware that USA Judo sponsors, suppliers and licensees provide critical support for the Team and, in recognition of this fact, I will wear designated USA Judo apparel at all official Team functions and events;
- will not conceal or cover-up any USA Judo sponsor, supplier or licensee brand or other identification appearing on my USA Judo apparel;
- agree to be filmed and photographed by the official photographer(s) and network(s) of USA Judo under conditions authorized by USA Judo and give event organizers and USA Judo the right to use my name, picture, likeness, and biographical information before, during and after the period of my participation in these activities to promote the activity in which I participate or to promote the success of the team on which I compete; in no event may USA Judo or the event organizers use or authorize the use of my name, picture, likeness, voice and biographical information for the purpose of trade, including any use in a manner that would imply an endorsement of any company, product, or service, without my written permission;
- will not use or authorize the use of photographs, films or videos of myself in my USA Judo apparel or equipment or the use of the USA Judo logo for the purpose of trade, without the prior written consent of the USA Judo (which consent shall not be unreasonably withheld);
- will act in a way that will bring respect and honor to myself, my teammates, USA Judo and the United States; and
- will remember that at all times I am an ambassador for my sport, my country and the Olympic Movement.
